- 4. AB 361

Elizabeth Goldman

Elizabeth Goldman Council noted that the Governor's Emergency Order expires on March 31, 2022. MSP (Graf/Maghsoudi) to reaffirm the resolution attesting to a continued state of emergency and need to follow the provisions allowed by AB 361: Be it resolved that the SCLC Administrative Council reconsidered the circumstances of the state of emergency declared by the Governor and at least one of the following is true: (1) The state of emergency, continues to directly impact the ability of the members of this legislative body to meet safely in person; and/or (2) State or local officials continue to impose or recommend measures to promote social distancing. (32 yes, 0 no, 0 abstain)

- 5. CLOSED SESSION Elizabeth Goldman Public Employee Appointment: Interim Executive Director, pursuant to Gov. Code Section 54957(b) Closed session began at 11:16am.
- 6. Reconvene to Open Session Elizabeth Goldman Open session began again at 12:11pm. Council affirmed that no decisions were made during Closed Session.
- 7. Approve Interim Executive Director Elizabeth Goldman Appointment and Compensation MSP (Graf/Addington) to appoint Heather Cousin as interim Executive Director of SCLC and enter in an agreement with Ms. Cousin for a term of 7 months. (27 yes, 0 no, 2 abstain)
- 8. Modify Signature Authority Elizabeth Goldman MSP (Addington/Shaffer) to authorize SCLC staff to update the Pacific Western Bank signature authority, and transfer signature authority to the interim Executive Director. The Chair, Vice Chair, and Project Manager retain signature authority as previously approved. (28 yes, 0 no, 1 abstain).
